The bids received in any other freely convertible currency(maximum up to three) will be converted to Afghani as per rate of exchange (selling rate) published by the Da Afghanistan Bank based on rate of exchange (Transfer Selling rate) prevailing on the date of bid closing and contract will**



be concluded in AFN. The document will be sent as well by email upon a scanned signed application.
